Please take note of the revised remuneration and make the necessary updates accordingly.

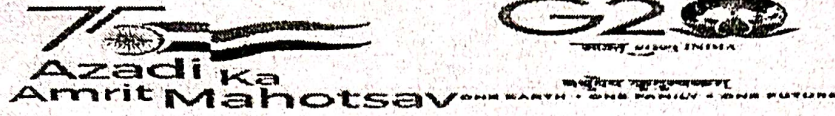
